The passage and adoption of said ordinance having ben concurred in by a majority of all members of the Board of Trustees, the chairperson declared adopted and the clerk attested the passage and approval of the same and affixed her signature thereto and ordered the ordinace to be published as provided therein and to be posted in three public places in the Village of Sterling. A true, correct and complete copy of said ordinance was made a part of the minutes for reference.

Delinquent utility accounts were discussed and those in arrears will be notified and without service unless their bill is paid in full. It was noted that property owners must notify the village if there are changes of renters.
