Weiss made a motion to approve the minutes of the last regular meeting held January 13, 2009 and Wingert seconded the motion. Vote: yeas: all. Motion carried. Weiss made a motion to allow the bills as presented and Wingert seconded the motion. Vote: yeas: all. Motion carried.

LeRoy Riensche, utility superintendent, reported on these subjects: water main break; garbage company contacted about more totes; fire hall window replacement; pickup in need of repair.

Fire Chief, Steve Weiss, reported that pagers have been repaired and that a UHF radio can be installed with Sterling Rural Fire Department sharing the costs.

John DeFreece, NPPD, representative, was present to meet the new board members. Chairman Heusman thanked John for his assistance in putting up the Christmas lights each year and replacing bulbs at the park yearly when necessary.

Wingert made a motion to allow a wage increase for village employees of three percent retroactive from January 1, 2009. Buss seconded the motion. Vote: yeas: all. Motion carried.

Wingert made a motion to adopt Resolution 2009-1 entitled, "A RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF STERLING, NEBRASKA, DETERMING THAT UTILITY ACCOUNTS OF CUSTOMERS OF THE VILLAGE

OF STERLING, NEBRASKA, ARE NOT AT RISK FOR IDENTITY THEFT AND DECLARING THAT NO RECORDS SHALL BE RELEASED TO THE PUBLIC, EXCEPT AS PROVIDED UNDER NEB.-STAT. SECTION 84-712.05". Rengstorf seconded the motion. Vote: yeas: all. Motion carried.

One zoning permit was presented and that was from St. John Lutheran Church for a new garage.

Richardson Tree Service will remove seven trees at the Sterling Cemetery for \$1600.00. Nemaha Natural Resource District representative, Chuck Wingert, discussed the Hazard Mitigation Plan and the various projects eligible.
