Vote: yeas: all. Motion carried.

Rengstorf made a motion to allow the bills as presented and Wingert seconded the motion. Vote: yeas: Heusman, Rengstorf, Wingert. Abstaining: Buss and Weiss. Motion carried.

Weiss made a motion to purchase two volt amp meters at a cost of \$50.00 each from Nebraska Surplus and Wingert seconded the motion. Vote: yeas: all. Motion carried. Heusman made a motion to purchase a shredder/mower if it deems suitable from Nebraska Surplus in the amount of \$1000.00 and Wingert seconded the motion. Vote: yeas: all. Motion carried.

Fire Chief, Steve Weiss, reported on these topics: hose drying system for the fire department and showed a new fire helmet. The cost of each helmet is \$150.00 and twenty-five are needed for the fire department. Heusman made a motion to purchase twenty-five helmets for the fire department and Rengstorf seconded the motion. Yeas: all. Motion carried. The cost will be shared equally with the rural fire department and the Village of Sterling. The department is checking into a telephone system for awareness in the event of a fire, tornado, etc.

A demolition permit was issued for a garage on Steve Eickhoff's property.

Wingert made a motion to approve a Liquor License from 1:00 p.m. July 11, 2009 to 1:00 a.m. July 12, 2009, for the Sterling Community Association. Heusman seconded the motion. Vote: yeas: all. Motion carried.
