Chairman Heusman reported on these items: the village box scraper is not for sale; camper pedestal for electrical hookups at the park; Stan Borcher bid for mowing, interseeding and snow removal at the cemetery will be on the April agenda; appointment of coaches and a director will be advertised prior to the April meeting.
