Rengstorf made a motion to allow the bills as presented and Weiss seconded the motion. Vote: yeas: Heusman, Rengstorf, Wingert. Motion carried.

The price may be increased if fuel costs are over \$3.00 per gallon. Kevin Heusman had a bid of \$745.00 for mowing the cemetery. Weiss made a motion to accept Stan Borcher's bid and Wingert seconded the motion. Vote: yeas: Rengstorf, Weiss, Wingert. Not voting: Heusman. Motion carried.

Michelle Salberg, Women of Today, representative in regard to the walking path at the Sterling Park. If the grant from NRD is approved the cost will be \$10,000.00 with matching funds. Planting trees, shrubs, grass and installation of lights are included in the grant with a timeline of July 1, 2009. A cooperative agreement needs to be signed upon approval of the grant. Pledges can be taken by May 1, 2009, and payable to the Sterling

Community Association. Wingert made a motion that the Village of Sterling pledges \$2500.00 for the walking path project and Weiss seconded the motion. Vote: yeas: all. Motion carried.

The Conradi property cleanup is progressing.
