Chairman Heusman acknowledged the Open Meetings Act and location on the north wall of the Sterling Fire Barn. Weiss made a motion to approve the minutes of the August 13, 2013 meeting and Rengstorf seconded the motion. Vote: yeas: all. Motion carried. Buss made a motion to allow the bills to include payment to Roger Huls for Gravely mower repairs of \$73.21 and Rengstorf seconded the motion. Vote: yeas: all. Motion carried. Jeff Bessey inquired about a permit for building a shed on Highway 41, formerly Al Lempka Heating. Dimensions were 64' by 27'. No action taken as the Planning Commission will have to make a recommendation in regard to the set backs. Action will be taken on the regular October meeting.

Street improvements and patching will be completed by Pavers as there are no other contractors were interested in this small project. Work could possibly be done by the end of the month.

Tim Norris, Home & Farm Insurance, was present to review the village's policy renewal at the end of the fiscal year. Discussion followed.

The removal of an unauthorized tree removal by Richardson Tree Service for a Sterling resident was discussed., No action taken.
